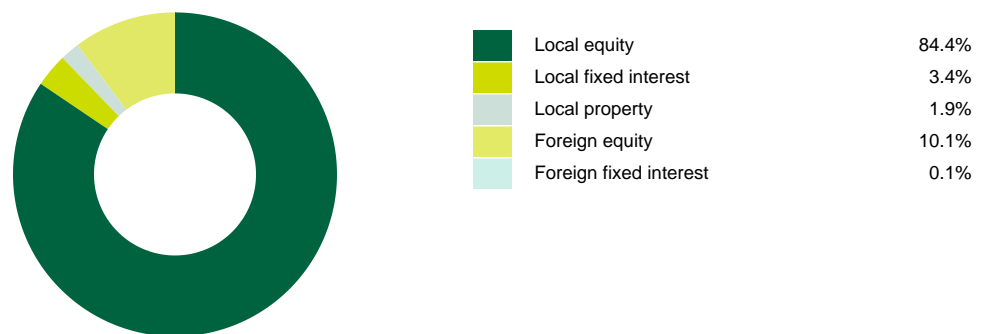

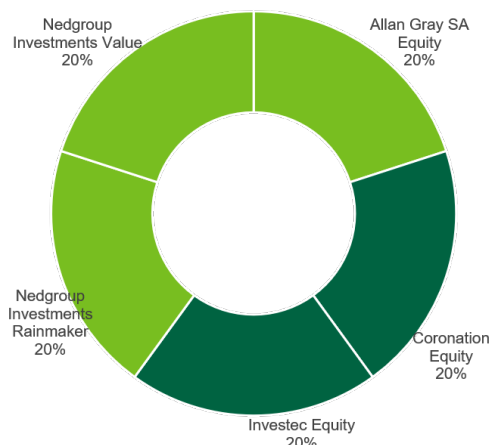

## Portfolio attributes

The XS Select Fund of Funds range consists of simple, low-cost investment solutions that offer broad diversification across asset classes, fund managers and investment strategies, which can easily be incorporated into a financial planning process. Each solution is equally weighted across five fund managers. Rebalancing, back to the target weights of 20% per fund, takes place on a quarterly basis. Importantly, no performance fees are charged.



60% is invested in actively managed South African equity funds that are only allowed to invest in shares listed on the domestic stock exchange.

40% is invested in actively managed South African equity funds that are allowed to invest up to 30% in shares listed on stock exchanges outside of South Africa.

Each of these fund managers have their own unique style and full discretion on stock selection. We believe as a combined solution these funds will most consistently achieve the XS Select Equity objective of SA Inflation + 6.5% over a rolling 7-year period, with the added benefit of lower volatility.
